Re: OPERATIONAL UPDATE START OF SEASON THROUGH 6/22/25

The inspection/treatment cycles of all sources for the current season was formally started in April. Covid-19 protocol utilized in the past will continue to be utilized during the current season. General larval operational crews will remain reduced from two to single member crews. To offset this reduced staff level, the use of Altosid pellets will continue in general larval operations to extend inspection/treatment cycle windows. We finished our second round for all Altosid pellet designated sources and are finishing our fourth round of all other sources.

The treatment of curbside stormwater catch basins started for the current season on May 5. During 2025, a variety of larval control products will be utilized in catch basin operations. Existing inventory of Altosid 30-day briquets is being used up in the first round. VectoLex and Sumilarv WSP Sachets are also being used in the balance of catch basins for the first round. A second round with VectoLex will then be completed, followed up with a final treatment round with Sumilarv WSP Sachets. We are 75% complete in our second round treatment.

The treatment of off-road stormwater catch basins started for the current season on May 5. VectoMax is being used for all treatment rounds. We are 25% complete in our second round.

- 5,382 VectoMax Packets in off-road catch basins
- 2 VectoMax Packets in general larval operations
- 381 lbs Vectobac-G Granular BTI in general larval operations

- 2.7 gal BVA-2 Larvicide Oil in general larval operations
- 0.0 gal Duet ULV concentrate for adult control operations
- 0.0 gal Remoa-Tri for adult control operations

(*) **Above insecticide totals will be updated on a monthly basis in lieu of weekly basis.**

The network of 8 New Jersey Light Traps was placed into service on May 11. The network of 18 Gravid Traps was also placed into service on May 11. PCR test results for WNV are included in the attached sheet. A total of 397 tests have been completed through June 22 with 6 positives found. Our pools are now being tested for SLE as well, with no positive results to date.

Two tick drags have been completed, with 6 male and 8 female American Dog Ticks collected.

Collection of used, abandoned tires is ongoing with appropriate disposal through the Illinois EPA. A total of 188 tires have been collected during 2025 to date.
